**6.4 Pawderosa Ranch** agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly stocked and sanitary. These measures and proper practices shall consist of: cleaning, lodging, exercising and training all dogs are cared for by Pawderosa Ranch staff without liability to Pawderosa Ranch for the loss or damage from theft, death, fire, theft, damage, injury, or illness to persons, other dogs, or property, and dogs, or for other non-included items, the care and obligations herein are assumed. It is expressly agreed by Owner and Pawderosa Ranch that Pawderosa Ranch's liability shall be limited to the extent of the actual dollar value of any of the above specified items to the extent of \$250.00 per animal admitted.

**6.5 The Owner** agrees to be fully responsible for making provisions against and against illness and injuries with expenses by maintaining adequate health care records and also agrees to notify Pawderosa Ranch of any serious injuries of the dog's a contagious, life-threatening disease, or other serious condition of a contagious nature, as reported by Pawderosa Ranch, the Owner, the veterinarian, or the dog's owner. If a serious condition of a contagious nature is reported, the Owner shall immediately notify Pawderosa Ranch and the veterinarian. The Owner shall be responsible for the cost of any necessary treatment and any other expenses. It is expressly agreed by Owner and Pawderosa Ranch that Pawderosa Ranch's liability shall be limited to the extent of the actual dollar value of any of the above specified items to the extent of \$250.00 per animal admitted.

Pawderosa Ranch reserves the right to take a substitute to Owner's dog for any reason at any time. Owner also agrees to take full and complete responsibility for any damage or injury caused thereby by the behavior of their dog, animals within dog group, or property.

**6.6 In the Event of an Emergency** Pawderosa Ranch staff will first attempt to contact the owner, followed by an attempt to contact the veterinarian. If the veterinarian cannot be reached, Pawderosa Ranch staff may take any action necessary to protect the health and safety of the dog, other dogs, or property.
