Powderosa Ranch agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility property enclosed and sanitary. Owner agrees and accepts potential risks involved in Dogcare, Grooming and Training. All dogs are cared for by Powderosa Ranch staff without liability of Powderosa Ranch's pet care services, Grooming and Training. The staff works hours of 9am to 6pm, other days or programs to be used during or for other unavailability, such as, but not limited to, illness, travel, vacation, or other staff unavailability. In no event shall the liability of Powderosa Ranch exceed the actual value of a pet of the same species or the sum of \$200.00 per animal combined.

I recognize that **THERE ARE INHERENT RISKS OF LIMBS OR INJURY** when dealing with animals. Such risks include, but are not limited to, problems resulting from rough play and sudden elements.

Notice: Per Texas Law (96206), Chapter 92A, Powderosa Ranch hereby informs Owner that dogs will be left unattended but supervised overnight from 7:00 p.m. to 6:30 a.m. every day of the year. Also, Owner is informed that there is no fire protection sprinkler system in the facility.

I understand and agree that **MY DOGS WILL BE LEFT UNATTENDED BUT SUPERVISED** overnight from 7:00pm to 6:30am every day of the year.

Owner agrees to take full responsibility for holding procedures against contagious illness and genetic exposure by consulting their vet veterinarian, and also agrees to notify Powderosa Ranch of any known exposure of the dog(s) to a contagious disease. Owner agrees to maintain certain restrictions as required by Powderosa Ranch. Illness, Injuries, and/or Accidents. Owner agrees to provide proof of preventative health care and to be financially responsible for any required treatment for illnesses, if determined necessary by Powderosa Ranch. By signing this Agreement and leaving the dog(s) with Powderosa Ranch, Owner certifies to the accuracy of all information given about said dog(s) and accepts all risks of injury incurred in Dogcare, Grooming and Training.

Powderosa Ranch reserves the right to deny admission to Owner's dog(s) for any reason at any time. Owner also agrees to take full and financial responsibility for any damage or injury caused directly by the behavior of his/her dog(s) towards another dog, person, or property.

I understand and agree that in accepting my dog(s) to Powderosa Ranch, the facility has relied on my representation that **MY DOGS REMAIN IN GOOD HEALTH AND HAVE NOT HARMED** or shown aggressive or disruptive behavior towards any person or any other dog.

I agree that **I WILL ASSUME FULL FINANCIAL RESPONSIBILITY** for any damage or injury caused directly by the behavior of my dog(s) to another dog, person, or property.

In the Event of an Emergency: Powderosa Ranch staff will first attempt to contact the owner, followed by an attempt to contact the emergency contact person listed. Powderosa Ranch may also directly contact the veterinarian listed, or an alternate veterinarian if the emergency contact person cannot be contacted. In an emergency, Powderosa Ranch staff shall make decisions on the best course of action, without liability, and the Owner of the dog(s) agrees to pay for all medical treatments received, including transportation to a veterinary facility.

I understand and agree that any problem that develops with my dog(s) will be treated as deemed best by Powderosa Ranch staff, at their sole discretion, and that **I ASSUME FULL FINANCIAL RESPONSIBILITY** for any and all expenses involved.

Changes Are to Be Paid Upon Departure of the Dog from the Facility. Owner agrees that the dog(s) shall not leave Powderosa Ranch until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties. Dog(s) must be paid up to date from 11:00am Monday through Friday, 11:00am on Saturday and 10:00pm-Sunday. A late charge of \$1.00 per minute after the time listed above will be applied and Owner agrees to pay this charge. All extra charges incurred by Owner shall be payable upon pickup of the dog(s) at Powderosa Ranch or the destination. Powderosa Ranch staff care, and a facility granted a lien on the dog(s) for any and all charges incurred resulting from services provided by Powderosa Ranch. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, Powderosa Ranch may exercise its lien rights upon the dog, without notice given by Powderosa Ranch to Owner by certified mail to address shown on the Registration Form, Powderosa Ranch may
